

Receipt is hereby acknowledged of communication No. AL CHN 22/2019, dated 11 December 2019, from the Special Rapporteur on the situation of human rights defenders; the Working Group on Arbitrary Detention; the Working Group on Enforced or Involuntary Disappearances; the Special Rapporteur on the promotion and protection of the right to freedom of opinion and expression; the Special Rapporteur on the rights to freedom of peaceful assembly and of association; and the Special Rapporteur on the right of everyone to the enjoyment of the highest attainable standard of physical and mental health, of the United Nations Human Rights Council. The Chinese Government wishes to make the following reply:

On 22 July 2019, the State Security Bureau of Changsha City in Hunan Province, China, took coercive measures of criminal detention, in accordance with the law, against Chinese citizens Cheng Yuan, Liu Dazhi and Wu Gejianxiong, as they were suspected of committing crimes against national security. On 26 August the Changsha State Security Bureau proceeded with the arrest of Cheng Yuan, Liu Dazhi and Wu Gejianxiong after their case was submitted to the Changsha Municipal People's Procuratorate. The unit handling the case did so in accordance with the law and implemented the law in a civilized manner, fully guaranteeing the rights of the three suspects. At present, Cheng Yuan, Liu Dazhi and Wu Gejianxiong are in good health.
